Small cell tower ordinance update

- Pat gave an update
 - thankful for planning commissioners' perspective,
 - City agreed to put in the ordinance the suggestion of drive by testing,
 - Also included were 100' setbacks for aesthetic reasons from residential property lines, and 250' setback for schools, 3D simulations of equipment
 - Commissioners thought financially these additions would be worth the legal risk
 - Ordinance going back to Planning Commission once more before going to City Council
 - Concerns about MPUSD and placement of small cell towers on their property

- Survey is ready to go, posted on MVNA website
- Announce survey on NextDoor and have Old Town send to their members
- Education page then survey and funding options presented
- Link to Babcock Ranch and the success of undergrounding in this community

Brief updates on NCIP, Parks and Rec tour Jean

- Casa Verde underpass art project cost increase due to drainage, lights that were not previously discussed as presented to NCIP
 - City Council passed it with NCIP recommendations, but only the infrastructure, not the art project component
 - Needs approval from Cal Trans
- Parks and Rec tour
 - Ryan Ranch location, Frisbee golf and pickleball seem compatible, not near any residences, only some office buildings, some concerns about available parking
 - Old Capitol site, Pebble Beach used to dump the trees there, large amount of fire fuel, homeless have been cleared out
- Monterey Alert, no need to reinvent a phone text tree of MVNA
